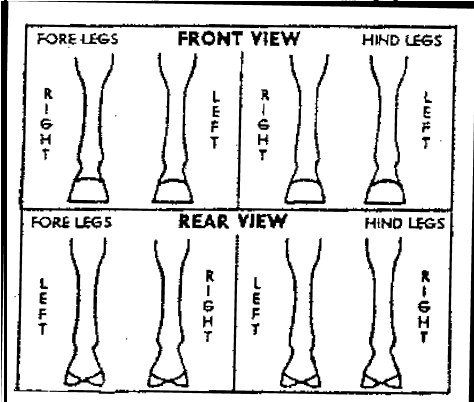
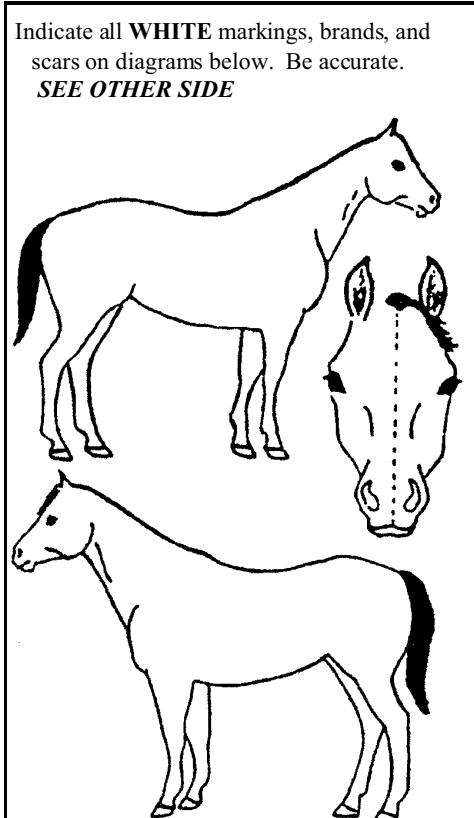

INSTRUCTIONS FOR REGISTRATION APPLICATION
Please Read Carefully

Accurately kept records are essential. In any case, where an application is regarded as questionable, the burden of proof rests upon the applicant who shall sustain his claims by a preponderance of evidence.

SECTION ONE: Be sure to give three name choices when filling in this application. You may not duplicate the name of any other horse registered with the registry. An apostrophe is the only punctuation allowed in a name. If you give only one name choice and the name has already been used, there will be a delay in the processing of your certificate. To save time, ABRA will select a name that has not been used if you so indicate. Fill in all information carefully and accurately. If unknown, write unknown in the blank. White sclera in eyes or striped hooves will in no way affect the acceptance of your horse for registration.

SECTION TWO: Fill in all known information regarding the pedigree of your horse. This is to be done for sire and dam in section two and for all three generations in the pedigree chart below. When pedigree is claimed, we must have some sort of proof as to this pedigree. Please furnish either a breeder's certificate (or a copy of same), a copy of registration certificate from another recognized registry or some other reasonable proof. If you are unable to furnish ABRA proof of your horse's pedigree, it will be listed as unproven.

SECTION THREE: Fill in your natural signature, then print or type your name carefully in the space provided. Give your complete address, including Zip Code. **HORSES MUST BE REGISTERED IN THE EXACT NAME(S) AS YOUR MEMBERSHIP.**

IMPORTANT!

When you have completed both sides of this registration application, mail it to ABRA along with the following...

- 1) The appropriate fee from table below. Your registration application will not be considered without the appropriate fee.
- 2) Eight (8) good quality color photos of your horse (no instant film, no digital photos, and no photos of body clipped horses). They must show each side, the front and the rear of your horse. The horse should be standing on smooth ground so that all white markings are shown clearly. The foretop should be pulled aside to show all face markings clearly. Photos of "Dun Factor" markings (if any are present) should be sent to help us determine color eligibility.
- 3) A copy of a breeder's certificate or registration papers from some other recognized registry. Proof of pedigree may be furnished below or on a breeder's certificate attached to this application. (*You must have owners signatures*).
